SGAA Bylaws: Article III; Section 1C, Categories: Affiliates. Affiliates shall be eligible to serve on committees and in some cases serve as Committee Chairs. Student Affiliates shall be registered for a course of study offered by a secondary school, college or university. **1E Related Professions Affiliate.** A Related Professions Affiliate shall be any individual who is engaged as a professional in any number of disciplines that are related to the craft of stained and/or art glass (i.e., Architects, Interior Designers, Building Contractors, Art Historians, etc.).
